YOUR SCHOLARSHIP APPLICATION

The scholarship application that follows on pages 2 - 5 is a very thorough form, requiring detailed information. Please understand that this particularization is not for the sake of complicating your request, but on the contrary, it is intended to ultimately work to your advantage, as it will enable the committee to screen applications upon the basis of genuine need. It is therefore most important that you thoroughly complete each section of the form. If you require any assistance in completing your application, please feel free to call 856-874-1500 and make an appointment with one of our staff members who will gladly guide you through it.

APPLICATION REQUIREMENTS

The scholarship application does not take the place of the regular camp registration form. If you did not receive a camp brochure and registration form along with this pamphlet please call our office and request one. Please do not submit your scholarship application without the following items:

- A) Appropriate deposits for each child
- B) A fully completed scholarship application. Incomplete applications cannot be processed.
- C) A Copy of your latest tax return. Applications unaccompanied by all the above will be returned to you unevaluated.

DEADLINE

All scholarship applications must be fully completed and submitted to the office no later than March 15 in order to be evaluated by the scholarship committee. The committee reserves the right to refuse any application received after this date.

SCHOLARSHIPS AND ADVERTISED DISCOUNTS

The granting of a scholarship is to the exclusion of all other discounts offered to the general public. The amount granted to you in scholarship assistance cannot be further reduced by early bird registration incentives or second-child discounts. However, if your scholarship request is denied, you will still be eligible for the early-bird discount if your application was submitted before the advertised cut-off date.

IMPORTANT NOTES

- * The submission of a scholarship application merely represents a request for scholarship assistance. It does not guarantee the granting of the request.
- * Scholarship grants apply to tuition costs only- No scholarships are awarded towards bus transportation, extended-care, camp shirt or hat fees. Furthermore, scholarship candidates will be required to pay the same trip and extra-curricular activities fees as do all campers of Camp Gan Israel.
- * Parents whose children have been awarded scholarships will be called upon to volunteer for trips, cooking etc.
- * All information provided on the scholarship applications will be kept in strictest confidence
